**CORRIGENDUM**

In compliance of interim orders dated 21-07-2010 of Hon'ble Punjab & Haryana High Court, in civil writ No. 6581 of 2010—Narinder Bhargav V/s State of Punjab, after considering various representations received from PPS Officers, amended Seniority as per Table-I, II, III & IV were issued on 07-09-2010 vide orders No. 15/157/2008-1H3/3053-3057, dated 07-09-2010.

However, Table-IV which is not the seniority List of PPS Officers but is list of PPS Officers working on temporary posts only due to some wrong command (Glitch) in the computer, the names of promotee PPS officers were inadvertently shown arranged as per their date of joining whereas these should have been in the order of their inter-se seniority in their feeding cadre. When this amended/corrected seniority list was uploaded on the web site of D.G.P., Punjab this discrepancy has been brought to the notice of government. This discrepancy which has occurred due to wrong command to the computer, has been now rectified and amended Table II, III & IV have been finalized. Accordingly, amended/corrected Table-II, III and IV are substituted in place of earlier table II, III and IV already issued along-with amended seniority dated 07-09-2010.
