### **Subject Seniority list of Inspectors of Police.**

Please refer to this office memo No. 5746-80/E-I(I) dated 07.06.2011 and this office memo. No. 10557-98/E-I(3) dated 25.11.2014, on the subject noted above.

2. Inspectors Kulwant Singh No. 27/HPR (530/JR), Paramjit Singh No. 356/Jal, Harbhajan Singh No. 537/JR and others who were promoted as ASI w.e.f. 18.07.1990 and confirmed in the rank of ASI w.e.f. 17.07.1992 have represented to this office that they are to be promoted as Sub-Inspectors prior to the direct appointee of 1989-90 batch, as they were confirmed as ASI w.e.f. 17.07.1992, whereas direct appointee of 1989-90 batch have been confirmed w.e.f. 12.12.1992. The Committee has been constituted vide order No. 4761-65/E-I(3) dated 23.06.14 to go through the seniority based on Officers Committee report and recommend the anomalies, if any.

3. The representation of above Inspectors has been accepted and a revised seniority of Sub-Inspectors (from seniority No. 785 to 1511) has been issued vide this office memo. No. 10557-98/E-I(3) dated 25.11.2014. Accordingly, promotion list 'F' dated 01.02.2010 (seniority No. 1232 onwards), issued vide memo No. 5746-80/E-I(I) dated 07.06.2011, is required to be changed. A fresh proposed seniority of Inspectors from seniority No. 1232 to 1865 (list 'F' dated 01.02.2010 & 06.07.2011) has been prepared and a copy of revised seniority list of Inspectors has been posted on Punjab Police website i.e. [www.punjabpolice.gov.in](http://www.punjabpolice.gov.in).
