2. In compliance with the order/direction of the Hon`ble High Court passed on 16.12.2014 and subsequently in (1) CWP No. 4829 of 2011 (O &M) filed by SI Pardeep Singh and others., 2. CWP No. 6501 of 2013 (O &M), 3. CWP No. 8832 of 2013 (O&M), 4. CWP No. 9902 of 2013 (O &M), 5. CWP No.11081 of 2013 (O&M), 6. CWP No. 24914 of 2013 (O &M), 7. CWP No. 25959 of 2013 (O &M), 8. CWP No. 5806/2014 (O&M), 9. CWP No. 13859 of 2014 (O &M), 10. CWP No. 16313 of 2014 (O &M), final seniority list of in the rank of Head Constable, Asstt. Sub-Inspectors and Sub-Inspectors have already been issued.

3. A final seniority list of Sub-Inspectors (Distt. & PAP) upto 20.02.2008 has been circulated vide this office memo No. 283-382/E-I(3) dated 03.01.2008. On the basis of this seniority list a tentative seniority list in the rank of Inspector have been prepared keeping in view the following instructions/guidelines:-

- i. Officers who have been brought on list 'F' and further promoted to the rank of Inspector with immediate effect in exercising the powers under Rule 13.15 read with 13.21 are given same date of promotion in the rank of Inspector which they are already holding.
- ii. 295 Sports person who were promoted in excess of 10% quota have been reverted to C-II as per the orders of Hon`ble High Court in CWP No. 13788 of 1997 filed by Swaran Singh and other officials. As the Government had re-appointed them after giving relaxation in rules and also created cadre post for them, as such their names have been included in the seniority list. Sports person of district Cadre and others who were promoted excess of 10% quota have not been included in the seniority list as State Government had created diminishing cadre posts (207 and 393) for them as a personal measure. 41 officials of Armed Bns. were facing considerable loss of seniority and likely to be reverted to lower ranks on account of re-casting of seniority and to mitigate the adverse effect of reversion and avoid demoralization in the police ranks, the Govt. of Punjab, Department of Home Affairs and Justice vide his letter No. 04/21/2016-5G3/1126 dated 05.05.16 and No. 4/21/2016-5G3/1727 dated 22.06.16 had created additional 41 posts (SP/04, DSP/18, Inspr./11, Sub Insp./08) as Dying Cadre. As such, the names of officials/officers who falls in the list of 207, 393 and 41 are not included in the seniority list.
- iii. The women who were brought on list 'F' and promoted to the rank of

Inspector against their cadre posts have been placed in the seniority list from their actual date of promotion in the rank of Inspector.

4. You are requested to circulate this tentative seniority list of Inspectors amongst all the concerned officials/officers (**servicing/retired or promoted in higher ranks**) related to your offices. For DGP/Intelligence, Punjab, ADGP/Armed BNs, Jalandhar, All Commissioners of Police in Punjab, All Range DIsG in Punjab and AIG/GRP, Punjab Patiala (.). They are requested to certify **within 7 days**, after perusal of the record whether the particulars of official related to their offices (**servicing/retired/expired or on deputation**) are in order and the officials are eligible for promotion in the rank of Inspector from the proposed date. If not eligible, then the next date from which they will be eligible be intimated to this office.

If any official/officers have any objection regarding seniority, then his representation alongwith your comments may be sent to this office after verifying from the service records within a period of 10 days positively from the date of issue of seniority list through your office dealing hand. No representation will be entertained after the expiry of prescribed period of 10 days. If any issue raised by any official/officer which has already been decided before the finalization of seniority lists in the rank of HC, ASI and SIs will not be considered.

5. A copy of the tentative combined seniority list of Inspectors (PAP & Distt) is available on Punjab Police website www.punjabpolice.gov.in. Acknowledge its receipt.
