- 2. In CWP No 15496 of 2009 filed by Sub Inspector Gurbinder Singh No. 365/PR and another, CWP No 689 of 2010 filed by Manjit Singh and others, and Inspr. Pritam Singh No. 525/KPT ,the officers Committee constituted by the Hon'ble High Court of Punjab & Haryana, Chandigarh has made the following recommendations, which are duly approved by W/DGP/Punjab:-
- a) **Confirmation** is to be de-linked from availability of permanent posts in terms of Govt. instructions dated 8-04-1991. The Punjab Civil services (General and common conditions of services) Rules 1994 will be applicable w.e.f 4-5-1994.
- b) A Common working **seniority list** in the rank of ASIs, S.Is and Inspectors atleast from 1988 be determined.
- c) P.A.P is to be treated as a separate cadre
- d) Inter-se-seniority of directly recruited officials in a common examination should not be disturbed.
- e) Five probationer ASIs, who were recruited in 1998-99 batch allocated to PAP, may be transferred back to district Police and may assigned inter-se-seniority as per batch of 1998-99.
- f) Those Police personnel who have been transferred from PAP to the General Police district against the norms should be nullified and those transferred personnel be sent back to the PAP.
- g) Category of sports and who were granted exemption/promotion under rule 13.21 of PPR 1934 are being reviewed as per the recommendations of the officers Committee and their seniority will be included at a proper place later on.
- In view of the above recommendations, a tentative seniority lists of ASIs and S.Is w.e.f 1-1-1988 has been prepared.
- A copy of tentative Seniority list of ASIs and SIs is available on Punjab Police Website i.e **w.w.w.punjabpoliceindia.org**. The same may please be circulated amongst all the concerned officials serving under your control. These officials may be informed to

submit their objection/ representation through Range D.IsG, if any, within a period of 10

days from the date of issue of this letter alongwith your comments. No

representation/objection will be entertained after expiry of prescribed period of 10 days. If

no objection is received from any official (s), it will be presumed that they have no objection

about the fixation of this seniority.

4. For All D.I.G/ Ranges, Commissioners of Police and AIG/GRP/Pb/Ptl Only: . They

are requested to examine their records, whether their service records is satisfactory and

they fulfill other eligibility conditions on that revised date of promotion given in the revised

seniority. If they are not eligible on that revised date, then intimate the revised date

alongwith reasons within a week positively.
