ORDER

The State Govt. vide his letter No. 1/40/2011-2H1/2280 dated 09.06.11 and Memo No. 1/40/2011-2H1/2376 dated 14.06.11 had created 207 posts in various ranks of sportsmen. Thereafter, the State Govt. vide his letter No. 1/40/2011-2H1/1530 dated 17.04.12 and Memo No. 1/268/2012-2H1/1457 dated 14.05.13 has decided to give them seniority/promotion list 'F' from the dates on which their juniors as Sub-Inspector given. In compliance with Hon'ble High Court orders in COCP No. 1492 of 2015 in CWP No. 4829 of 2011, vide this office memo No. 3283-382/E-1(3) dated 03.01.2018 and No. 14180-280/E-I(3) dated 30.10.2018, revised seniority of Sub-Inspectors have been issued.
