2. At present there are 534 Inspectors of Police in Position. As per Punjab Police Act 2007, police force is divided into four cadres. Seniority lists of Distt. cadre and PAP cadre have been prepared on the basis of unit from which the recommendation/seniority of SIs for 'F' list was received in this office. Thus those who came into list 'F' from PAP cadre have been accommodated within that cadre as per the recommendation of the Officer Committee. The existing Inspectors are hereby allocated permanently in two cadres as follows:-

- i. Distt. Police Cadre : **275 (list enclosed)**
- ii. Armed Police Cadre : **259 (including 62 Insprs. on deputation (53 in Int. Wing & 9 in Vig. Bureau)(list enclosed)**
