Regarding withdraw of Final Seniority list of HC, ASI, SI and Inspector (Operator & Technician) Cadre of IT&T Wing after implementation of "Ajit Singh Januja Judgement"

Kindly refer to the subject cited above.

2. The Final Seniority lists of HC, ASI, SI and Inspector (Operator & Technician) Cadre of IT&T Wing issued vide No.49820-912/E-1, No.49913-50008/E-1, dated 28.11.18 and corrigendum issued vide No51264-382/E-1, dated 7.12.18 are hereby withdrawn in view of clarification received from D.G.P. office vide No.15871/E-1(2), dated 31.12.18.(copy enclosed) It has now been clarified vide this communication dated 31.12.18 that if there is any

vacant post earmarked for reserved category in the roster, then a candidate from the reserved category cannot be denied his roster point promotion by modifying his Date of promotion' as equivalent to date of seniority. The date of promotion is to be treated as distinct and separate from date of seniority, although in certain cases they may be the same or may be different in certain other cases. It has been further clarified that assuming that there are two persons A and B belonging to general category and reserved category respectively, A being senior and B junior, Candidate B is promoted to the next higher rank on 25.10.2005 against roster point, while candidate A gets promoted to the same rank on 1.04.2007 on basis of seniority. Implementation of Janjua Judgement would mean bringing down candidate B in the seniority list at par with candidate A i.e. he will figure in the seniority list of 2007. However, the date of promotion of candidate B would remain unchanged at 25.10.2005. This would enable candidate B to get the benefit of qualifying service for roster-point promotion. However, for seniority-based promotions candidate B would have the seniority of 01.04.2007, despite his date of promotion being 25.10.2005.

3. Keeping in view the above clarification fresh tentative seniority will be prepared and published after approval of competent authority .
