Subject Tentative Seniority list of Inspectors of Police (Distt. Police Cadre).

Please refer to this office memo No. 3274-3373/E-1(1) dated 10.4.2016, on subject noted above.

2. In compliance with Hon'ble High Court order passed in CWP No. 4829 of 2011 filed by Pardeep Singh and others and 9 other CWPs, the final joint seniority list of Inspectors has been issued vide memo under reference.

3. Now, a tentative seniority list of Inspectors of Distt. Police Cadre (after 20.02.2008) has been prepared and the officials have been assigned proposed 'F' list. A copy of the Tentative Seniority list of Inspectors is available on Punjab police Website i.e. www.punjabpolice.gov.in. The same may please be circulated amongst all the concerned officials serving under your control. These officers may be informed to submit their representations, if any, by 20.05.2016 (Friday). No representation will be entertained after the expiry of prescribed period of 10 days. If no objection/representation is received from any officer it will be presumed that he has no objection about the fixation of this seniority. **For DGP/Int., all CPs, All Range DIsG and AIG/GRP, Pb, Patiala only.** They are requested to scrutinize the service record of all the officials/officers mentioned in the proposed list 'F' seniority and certify within 5 days (i.e. by 20.05.2016) that they are eligible i.e service record satisfactory from the date they are assigned proposed list 'F' and those officials who are not eligible for list 'F' from the proposed date, detail of these officials/officers may be intimated and also intimate the date from which they will be eligible for next 'F' list or otherwise. They are also requested that while scrutinizing their eligibility for list 'F' dated 20.09.2012 and thereafter, their last 5 years ACRs number may also be counted which should be 10 minimum.
