3. You are requested to hold the meeting of Departmental Promotion Committee and consider the cases for promotion and if any, vacancy remains unfilled the same may be intimated to this office immediately.

4. While issuing promotion order it may be ensured that the service record of the individual is complete in all respects and is satisfied, that they are not under suspension and that they are not facing D.E/Criminal case and nothing is otherwise adverse against them.

5. The Punjab Civil Services Rules (General and Common Conditions of Service Rules) 1994 have been applicable w.e.f. 04.05.1994. As per rule 18(2), if any Govt. employee refuses to accept promotion, he shall be debarred by the appointing authority from consideration for promotion for all the consecutive chances, which may occur in future within a period of two years from the date such refusal to accept promotion.

6. It is also intimated that all the promotions shall be subject to the final decision of Civil Writ petition(s) pending in the Hon'ble High Court in this regard.
